#### Welcome - Call to Order:

Chair Tracy called the meeting to order at 3:00pm. Roll call read by Cindy Mayer. Quorum present.

#### **Approval of Meeting Minutes:**

Minutes for the March 17, 2025, Youth Committee meeting was approved as is. Kala Lambert made the motion to approve the minutes. Kelly Denton seconded the motion. Motion carried.

#### **Committee Goals and Direction:**

Cindy Mayer proposed a mission statement and strategies for the committee based on the result of the survey committee members completed. The group liked the mission statement and strategies and felt we should proceed in this direction with the committee.

#### Misson:

Collaborate with businesses and community resources to create opportunities that support youth, from all walks of life, to enter the workforce through education, skill building, and work experience.

#### Strategies:

- Coordinate youth services and put forward eligible youth service providers
   Discussion was held on creating a referral guide for partners, utilize a link on LWA23
   Website, and build from the asset map that already exists.
- 2. Develop an outreach plan that will reach youth, particularly those less likely to engage, to inform them of services available

Discussion included Kelly Denton offering the outreach plan used by her staff that was successful in recruiting youth. Carolynne suggested collaboration with DCFS and is willing to look into this collaboration. The group then brainstormed other potential resources for recruitment of youth including probation, substance abuse treatment centers, church groups, mental health providers, hospitals, police, and

- housing authorities. The idea of hosting periodic Zoom chats for youth to join to learn about services was also mentioned.
- 3. Recruit businesses willing to assist youth in gaining work skills and experience Ed shared he thinks Chambers would be willing to help recruit businesses. He shared his experience with someone placed in his office and it was successful. It was also suggested we utilize Chamber Newsletters to recruit and the use of testimonials from businesses that have had youth through one of our programs would be powerful.

#### **Youth Programs and Activities:**

Kelly Denton shared the WIOA program is exceeding their benchmarks after implementing their recruitment plan last year and the program is receiving an increase in funding for PY 25. Joy Fits shared information about Kaskaskia's manufacturing certification program that will be for 1 semester and is 16 credit hours. Additionally, courses will transfer into other programs. Kala Lambert provided information on the Clean Energy Career Pathway Program which is a grant opportunity and focuses on "in-school youth".

Carol Tracy, shared ERBA offers a program that assists youth in paying for extra-curricular activities such as camps and sports. This is offered through their CSBG funding.

Carolynne shared DRS is transitioning their high school graduates into the adult program. All services provided by DRS are still available and doing well.
